In reference to DepEd Memorandum No. 024, s. 2024, the Department of Education (DepEd) through the Bureau of Education Assessment (BEA) This Office through the Curriculum Implementation Division (CID) will administer the **National Achievement Test for Grade 6 (NATG6)** for School Year 2024-2025, pursuant to DepEd Order No.55 s.2016 titled Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program on **March 31** and **April 1-4, 2025** as testing window to public and private elementary schools operating with permits.

- The **NATG6** will be administered on a paper -based modality to all regional offices (ROs), schools' division offices (SDOs), public elementary and private schools operating with permits.
- The **NATG6** is an exit assessment that is designed to determine if Grade Learners are meeting the learning standards in the elementary curriculum. The test design to measure the five learning areas (**English, Mathematics, Science, Filipino and Araling Panlipunan** ) in a multiple -choice format.

- The Language of the Testing for the following areas are as follows:

<b>Language of Testing</b>	<b>Learning Areas</b>
English	English, Science and Mathematics
Filipino	Filipino and Araling Panlipunan


- The BEA will manage the national implementation of the NATG6 with the assistance of the ROs and SDOs.
- This division office will conduct an **orientation** for School Heads/ Principals and SDO Private School Principals on the administration of tests on **April 01, 2025, at 8:30 am** at the Division Conference Hall, DepEd Division Office, Provincial Sports Complex, Bolbok, Batangas City.
